Photos will be selected by the COPR Administrative Team from eligible submissions and will be judged based on the extent to which they exhibit a sense of such qualities as:

- Innovation,
- Collaboration,
- Community Spirit,
- Teamwork, and
- Safety.

Send us your community events shots, your paramedics in action shots, and any other shots that capture your proudest moments! To be deemed eligible, participants must abide by the COPR Photo Contest Rules and Instructions and include the signed Photo Contest Waiver.

All entries must be received by email (communications@copr.ca) prior to 1700 hrs (CST) April 3, 2023.

COPR Photo Contest Rules and Instructions

ELIGIBILITY

All submissions must be photographs taken within Canada. COPR reserves the right to cancel the Contest or modify these rules at its discretion. Decisions of COPR will be final. No purchase is necessary.

FORMAT

Only high-resolution digital photographs of at least 600 dpi submitted electronically in jpg format will be accepted.

For each photo submitted, you must identify:

- the names of those in the photo,
- the name of the photographer,
- the time and place of when and where the photo was taken,
- and a brief description of the image.

You can enter more than one photo for consideration.

For a photo in which a person is recognizable, **you must ensure the subject signs the Photo Contest Waiver**. This responsibility lies 100% with the person who submits the photo and must be submitted with all entries.

Photos, Photo Contest Waivers and accompanying identifying information are to be emailed to communications@copr.ca with subject line "COPR Photo Contest" prior to 1700 hrs (CST) April 3, 2023.

Permitted:

- cropping of photos,
- colour corrections.

Not Permitted:

- borders,
- photo collages,
- text,
- product logos.

For photos in which the identity of a patient or person being provided care is visible, please include their signed consent in the Photo Contest Waiver for use.

Failure to comply with contest rules will result in your submission not being eligible for Contest. Late submissions will not be accepted.

ENTRIES AND IDENTIFICATION

Entrants must own all rights to the photographs submitted. As such, entrants hold COPR harmless from any breach of copyright. By your submission you agree to these contest rules and regulations. The signed Photo Contest Waiver must be included for each submission.

PUBLICATION

Winners' names and photographs will be published on www.copr.ca. COPR reserves the non-exclusive right to publish any entry and/or use any entry in promotional and advertising materials including social media channels.

JUDGING

The winners will be selected by the COPR Administrative Team. Winners will be notified by email **ONLY** by 1600 hrs (CST) April 28, 2023. Decision of the judges is final.

By uploading or submitting any photograph to this contest, the entrant grants (or warrant that the owner of such materials expressly grants) COPR a royalty-free, world-wide, perpetual, non-exclusive license to display, distribute, reproduce, and create derivative works of the entries, in whole or in part, in any media now existing or subsequently developed, for any COPR purpose, including, but not limited to advertising and promotional materials, its website, exhibition, and commercial products, including but not limited to COPR publications.
